# ARTICLES OF INCORPORATION OF GRAYWOLF SLEEPER SYSTEMS, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I.

NAME: The name of this corporation is GRAYWOLF SLEEPER

SYSTEMS, INC. and the principal place of business shall be 3274

Andy Lane, Crestview FL 32539.

#### ARTICLE II.

**DURATION:** The corporation shall exist perpetually.

#### ARTICLE III.

PURPOSE: The purpose or purposes for which this corporation is organized is to engage in design, development, sales/marketing, assembly and distribution of tractor trailer cabinet and storage systems and/or any activity or business permitted under the laws of the United States and the State of Florida.
