ARTICLES OF INCORPORATION



PINEMOOR GOLF, INC.



The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is PINEMOOR GOLF, INC., a Florida corporation, and the principal office is located at 4590 126th Avenue North, Clearwater, Florida 33762.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

This corporation shall exist perpetually.
