# ARTICLES OF INCORPORATION OF BARBARA JEAN BAILEY, P.A. 17730 OAK BRIDGE STREET TAMPA, FLORIDA 33647

The undersigned, has executed the following document as incorporator of the above named professional association, a professional association for the sale of real estate organized under the laws of the State of Florida, and those of the professional association for the sale of real estate, are to be determined in accordance with the laws of the State of Florida.

- To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of any instrumentality thereof,
- To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its property, franchises, and income;
- To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested;
- To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state;
- To elect or appoint officers and agents of the corporation and define their duties and fix their compensation;
- To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for the administration;


