ARTICLE I – NAME

The name of the corporation is Prolink International, Inc. (hereinafter called the "Corporation")

ARTICLE II – PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the laws of the United States and the State of Florida and, to the extent permitted by applicable law, to have and to exercise all of the powers necessary, convenient or incidental to carrying out any of such business within or without the United States.

Without in any way limiting the generality of the foregoing, the Corporation is organized primarily for selling, distributing, and exporting of commercial goods.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$ 1 per share.

Shares of capital stock of the Corporation that have been issued and subsequently acquired by the Corporation shall constitute issued but not outstanding shares of the same class and series, until canceled or disposed of (whether by resale or otherwise) by the Corporation. If the Board of Directors cancels any such shares, the canceled shares shall constitutes authorized and unissued shares of the same class and shall be undesignated as to series.

ARTICLE IV – INITIAL REGISTERED AGENT

The street address of the initial registered office of the Corporation is 3308 Torremolinos Ave, Miami, FL 33178; and the name of the initial registered agent of the Corporation at the address is Chiu-Shiow Pan.

ARTICLE V – INITIAL PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the Corporation is 2800 N.W. 72nd Avenue, Miami, FL 33122.

<u>ARTICLE VI – INITIAL BOARD OF DIRECTORS</u>

The Corporation shall have two directors initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one. The names and addresses of the initial directors are:
