Name**

The name of the Corporation is MARC Investments, Inc, hereinafter referred to as the "Corporation."

**II.
Purposes**

Operating Provisions

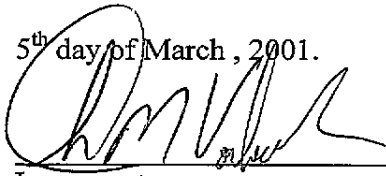

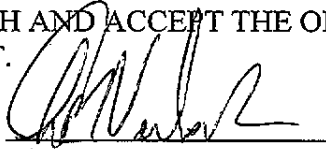
