The private property of the stockholders shall not be subject to the payment of corporate debts.

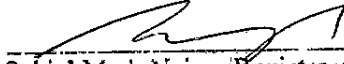

Fiscal Year

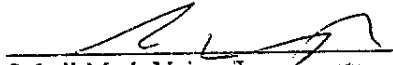
The fiscal year of the Corporation shall be from January 1 to December 31 of each year.
