

ARTICLE OF INCORPORATION

OF

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE TERMS OF THE FLORIDA GENERAL CORPORATION ACT DOES HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE ONE

NAME OF CORPORATION

ARTICLE TWO

PRINCIPAL OFFICE

ARTICLE THREE

PURPOSE




