ARTICLES OF INCORPORATION
OF
CUSTOM CLEANING GROUP, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

ARTICLE ONE

The name of the corporation is CUSTOM CLEANING GROUP, INC.

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation has the authority to issue is ten thousand (10,000), all of which shall be common shares with par value of one dollar (\$1.00) per share.

ARTICLE FIVE

The street address of the initial registered office of the corporation is 4868 N.E. 12TH Avenue, Oakland Park, Florida 33334, and the name of the initial registered agent at such address is ASRAF M. BHEGANI. The foregoing street address is also the principal office address of the corporation and the mailing address of the corporation.

ARTICLE SIX

The business of the corporation shall be managed by the shareholders of the corporation rather than by a board of directors.
