ARTICLE II NATURE OF BUSINESS

The corporation is in the business of operating a tire and wheel rental business. In addition, the corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.
