ARTICLES OF INCORPORATION

OF

MAJESTIC MEDICAL SERVICES, INC

ARTICLE I - NAME

The name of this Corporation is MAJESTIC MEDICAL SERVICES, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles of Incorporation are filed with the Florida Secretary of State's Office.

ARTICLE IV - CAPITAL STOCK


