ARTICLE 1-NAME

NATIONWIDE HEALTH INSTITUTE, INC.

ARTICLE 11 - DURATION

This corporation is to have perpetual existence.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and the State of Florida , specifically for the establishment of a school.
