ARTICLES OF INCORPORATION OF
S R & E SERVICES, INC.

ARTICLE I
CORPORATE NAME

The name of the corporation is S R & E SERVICES, INC.

ARTICLE II
DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK
