# ARTICLES OF INCORPORATION OF DUTY FREE INC



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE I – NAME

The name of this corporation is DUTY FREE INC.

#### ARTICLE II - PURPOSE
