Bylaws

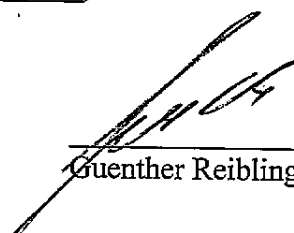

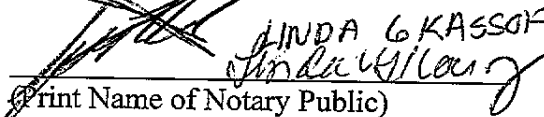

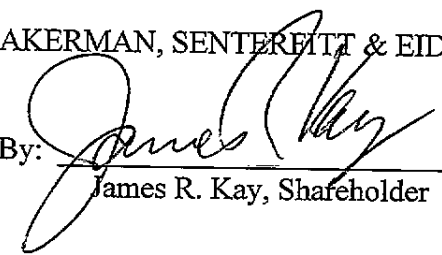
