

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

1. The name of the Corporation is Night Moves Entertainment, Inc. The period of duration of the corporation is perpetual.
2. The principal office of the Corporation shall be in Tallahassee, Florida. The Corporation may also establish any office or offices at such other place or places as the Board of Directors may from time to time designate. The mailing address of the Corporation shall be 513 Patty Lynn Drive, Tallahassee, Florida 32310.

3. Authorized Shares.

Number. The aggregate number of shares that the Corporation shall have the authority to issue is 100 shares of Capital Stock with a par value of \$1.00 per share.

Initial Issue. Ten (10) shares of the Capital Stock of the Corporation shall be issued for cash at a par value of \$1.00 per share.


Dividends. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the Corporation.

No classes of stock. The shares of the Corporation are not to be divided into classes.
