## ARTICLES OF INCORPORATION OF JAFFE OF POMPANO, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

### ARTICLE I

The name of the Corporation is Jaffe of Pompano, Inc.

### ARTICLE II DURATION

The term of existence of the Corporation is perpetual.

### ARTICLE III NATURE OF BUSINESS

The nature of the business to be conducted by the Corporation is:

- 1. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act;
