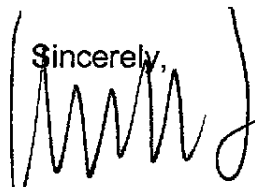

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be SEACREST MORTGAGE CONSULTANTS, INC.

ARTICLE II - CORPORATE ADDRESS

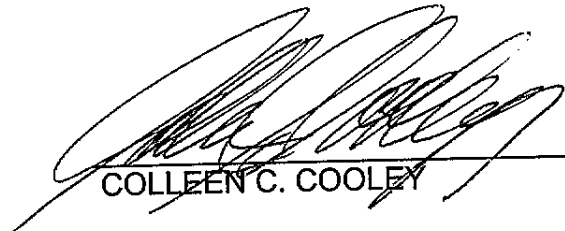
