

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:


FIRST: ARTICLE 3 of Q&A Communications, Inc.'s Articles of Incorporation shall be amended as follows:

This corporation is authorized to issue One Hundred Million (100,000,000.00) shares of common stock with no par value.
This corporation is also authorized to issue Thirty Million (30,000,000.00) shares of preferred stock with no par value.

SECOND: The date of the amendment's adoption: August 1, 2001

THIRD: The amendment was adopted by the board of directors without shareholder action and shareholder action was not required.


