Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: ARTICLE 3 of Q&A Communications, Inc.'s Articles of Incorporation shall be amended as follows:

This corporation is authorized to issue One Hundred Million (100,000,000.00) shares of common stock with \$.10 par value.
This corporation is also authorized to issue Thirty Million (30,000,000.00) shares of preferred stock with \$.10 par value.

SECOND: The date of the amendment's adoption: September 11, 2001

THIRD: The amendment was adopted by the board of directors without shareholder action and shareholder action was not required.


