ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name.

The name of the Corporation is: FORT MEADE LAND AND TIMBER COMPANY, INC.

Article II.

Duration.

The duration of the Corporation is perpetual.

Article III. Purpose.

The general purposes for which the Corporation is organized are the following:

Any limitation upon the transferability or assignment of stock shall be a valid matter of agreement which stockholders may include in any agreement among themselves.


