

The undersigned acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following articles of incorporation for such corporation:

*ARTICLE 1 - CORPORATE NAME*

The name of this corporation is BOBBY Z 'S ICE CREAM, INC.

*ARTICLE 11 - DURATION*

This corporation shall exist perpetually unless dissolved according to Florida law.

*ARTICLE 111-PURPOSE*

The corporation is organized for the purpose of selling and serving ice cream and other prepared food and any other activities or business permitted under the laws of a food and non-alcoholic beverage establishment in the United States and the State of Florida.

*ARTICLE 1V - CAPITAL STOCK*

The corporation is authorized to issue 1000 shares of common stock, par value \$1.00 per share.

*ARTICLE V - INITIAL PRINCIPAL OFFICE*

The street address of the initial principle office and mailing address is 302 Hwy. 26, Melrose, Florida, 32666.

## *ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT*


## *ARTICLE VIII- INCORPORATOR*
