My name is Mark Ardis and I recently had the opportunity to see Katherine Harris at the Grassroots Forum for people with disabilities in Orlando on 6/11/02. I was one of the delegate from my area to learn more of how to help other friends disabled like myself.

I want to briefly explain my situation and make my request. I have a small business which I incorporated last year in 4/01. I've been paralyzed for almost eight years but never had this type of fee in my old business. I've been unable to sustain any work to speak of do to all the variables I deal with to receive health benefits.

Earlier this week I found this notice in my mail requesting \$550.00 before 9/13/02 for this Uniform Business Report. I don't even have that in my account. I had no idea what the division of Corporations was doing. The fact is I never received a notice earlier this year about the initial fee that is required that I found out was supposed to be \$150. I called my accountant friend to find out what this is about, and he informed me. There is no way I can afford this fee, so let me know if they will waive the additional amount so I can get this issue resolved ASAP.
