I had no idea what the division of Corporations was doing. The fact is I never received a notice earlier this year about the initial fee that is required that I found out was supposed to be \$150. I called my accountant friend to find out what this is about, and he informed me. There is no way I can afford this fee, so let me know if they will waive the additional amount so I can get this issue resolved ASAP.
