ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE 1.

Name

1.1) Name. The name of the corporation is

ARTICLE 5.

Initial Registered Office and Agent and Principal Business Office

- 5.1) <u>Initial Registered Office and Agent</u>. The street address of the initial registered office of this corporation is <u>Rita A. Powers and Rights of Shareholders

8.1) Pre-Emptive Rights. The corporation reserves the right from time to time to amend, alter, or repeal, or to add any provision to, its Articles of Incorporation, in any manner now or hereafter prescribed or permitted by the provisions of Chapter 607 of Florida Statutes, or any amendment thereto, or by the provisions of any other applicable statute of the State of Florida; and all rights conferred upon stockholders by these Articles of Incorporation or any amendment hereto are granted, subject to this reservation.
