ARTICLES OF INCORPORATION OF

MIAPANAM INC.

ARTICLE I --- NAME

The name of this corporation is MIAPANAM INC.



ARTICLE II- EXISTENCE

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE - III- PURPOSE

This corporation shall have al least two Directors constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the rules set in the bylaws; however, there shall never be less than two Directors nor more than five.
