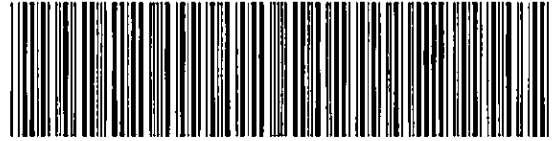

It is agreed that, upon the merger becoming effective, the surviving corporation:




