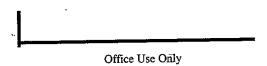

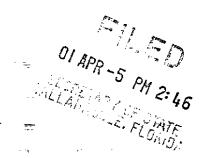

ARTICLES OF INCORPORATION

OF

AJ'S ENTERPRISES OF OLDSMAR, INC.
