**ARTICLES OF INCORPORATION
OF

ARTICLE I: NAME

The name of this corporation is Human Asset Management, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II: DURATION

The Corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

ARTICLE III: PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as it now exists or may hereafter be amended.

ARTICLE IV: CAPITAL STOCK

The Corporation is authorized to issue One Thousand (1,000) shares of no par value common stock which shall be designated as "Common Shares."

ARTICLE V: PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of the Corporation, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI: PRINCIPAL PLACE OF BUSINESS;
INITIAL REGISTERED OFFICE AND AGENT**

The street address of the principal place of business of the Corporation is 640 Fitzwalter Drive, Winter Park, Florida 32792. The initial registered office of the Corporation is 2265 Lee Road, Suite 103,

Winter Park, Florida 32789, and the name of the initial registered agent of the Corporation at that address is Richard Spice Wheeler, Esq.

ARTICLE VII: BOARD OF DIRECTORS

The Corporation shall have a Board of Directors consisting of as many Directors as are provided for in the Corporation's By-Laws, the number of which may be either increased or decreased from time to time by appropriate amendment to the By-Laws. However, there shall never be less than one (1) Director.

ARTICLE VIII: INCORPORATOR

The name and address of the Incorporator signing these Articles is Richard Spice Wheeler, whose address is 2265 Lee Road, Suite 103, Winter Park, Florida 32789.


ARTICLE IX: INDEMNIFICATION

The Corporation shall indemnify any officer, director or employee (or any former officer, director or employee) of the Corporation to the fullest extent permitted by law.

ARTICLE X: AMENDMENT

The Corporation reserves the right to amend or repeal any provision of these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.


