**ARTICLES OF INCORPORATION  
OF

The undersigned for purposes of forming a corporation under the Florida General Corporation Statute hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is T.J. DONGILLA & CO., INC.

**ARTICLE II - INITIAL PRINCIPAL OFFICE**
