ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida Business Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I--NAME

The name of this corporation is AIR COMM WIRELESS, INC., and the principal office is located at 2381 S.W. College Rd., Ocala, Florida 34474.

ARTICLE II--DURATION

The period of its duration is perpetual.

ARTICLE III--PURPOSE

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida; including wireless communication sale, service, and installation.
