ARTICLE I – NAME

The name of this corporation is Capecanaveral.com, Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal place of business of this corporation shall be 12734 Kenwood Lane, Suite 84, Fort Myers, FL 33907.

ARTICLE III – DURATION

The period of the corporation's duration is perpetual.

ARTICLE IV – PURPOSE

The purpose for which the corporation is organized is to engage in the transaction of any and all lawful business for which corporations may be incorporated under the provisions of the Florida General Corporation Act.

ARTICLE V – INITIAL REGISTERED OFFICE

ARTICLE VIII – INCORPORATORS

ARTICLE IX – PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale of cash of any new stock of this corporation shall have the right to purchase his prorata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.
