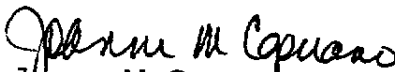

ARTICLES OF INCORPORATION

OF

STERLING CENTRECORP INC.

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I -- NAME

The name of the corporation shall be STERLING CENTRECORP INC. The principal office and mailing address of the corporation is 209 Phipps Plaza, Palm Beach, Florida, 33480.

The corporation shall have perpetual existence.

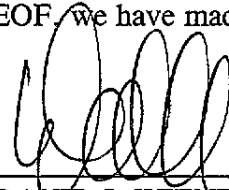

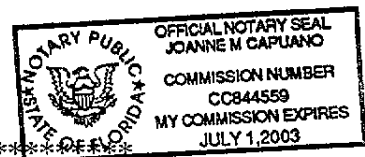

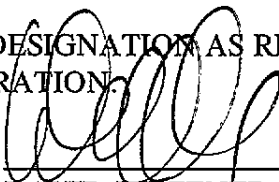
