By these Articles of Incorporation, the undersigned forms a Corporation under the laws of the State of Florida.

**ARTICLE I**

**NAME:** The name of this Corporation is:

ADVANCED DIGITAL SERVICES, INC.

**ARTICLE II**

**TERM OF EXISTENCE:** This corporation shall exist perpetually and shall commence upon the filing of these Articles of Incorporation by the Department of State.

**ARTICLE III**

**CORPORATE PURPOSES:** The corporate purposes are to engage in the transaction of any lawful acts, activities or businesses for which corporations may be organized under the laws of the State of Florida or the United States.
