**ARTICLES OF INCORPORATION
OF
ANGELO DUNDEE TRAINING CENTER, INC.**

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Angelo Dundee Training Center, Inc., and its address is 2240 S.W. 70th Avenue Bldg I, Davie, Florida 33317.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

- (1) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

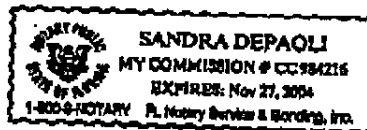
