The name and address of the incorporator of the Corporation is Udi Balva, 19190 Cloister Lake Lane, Boca Raton, Florida 33498.

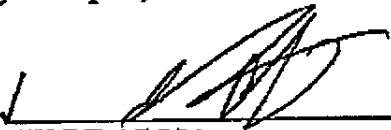
ARTICLE VI

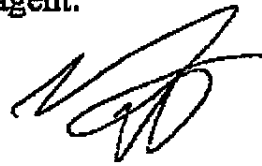
