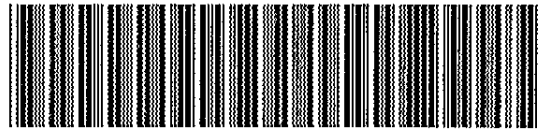

In accordance with section 607.1006 of the Florida Statutes, International Investment Group (IIG), Inc. (the "Corporation"), hereby adopts and files the following articles of amendment to amend the Corporation's Articles of Incorporation as follows:

1. Article III shall be deleted in its entirety.
2. The forgoing Article III, deleted by its entirety, shall be replaced as follows:

ARTICLE III

The purpose for which the corporation is organized is to transact any lawful business, including without limitation, all nature of business relating to property located within the State of Florida.
