ARTICLES OF INCORPORATION  
OF  
COMMONWEALTH TRADING CORPORATION

The undersigned, in order to form a corporation pursuant to the laws of the State of Florida, certifies in accordance with Chapter 607 and/or Chapter 621, F.S. (Profit) as follows:

ARTICLE I

The name of the Corporation is Commonwealth Trading Corporation.

ARTICLE II

The address of the registered /principal office of the Corporation is 1060 Kapp Drive, Clearwater, Florida 33765, which is located in Pinellas County.

ARTICLE III

The purpose for which the corporation is organized is to conduct a business for profit.
