**Article I. Name and Address**

The name of this corporation is Sun Graphic Technology, Inc.. The address of the corporation and the principal office of this corporation is 2310 Whitfield Park Avenue, Sarasota, FL 34243.

**Article II. Duration**

This corporation shall exist perpetually, commencing five days prior to the date of filing of these articles.

**Article III. Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.

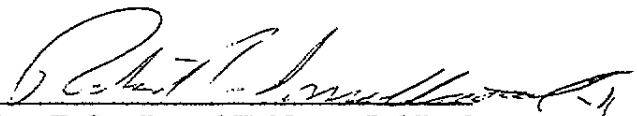

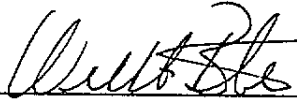
