

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as Incorporator of a corporation under the Florida Business Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I--NAME**

The name of this corporation is ARCHITECTURAL AUDIO & DESIGN, INC., and the principal office is located at 2381 S.W. College Rd., Ocala, Florida 34474.

**ARTICLE II--DURATION**

The period of its duration is perpetual.

**ARTICLE III--PURPOSE**

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida; including custom home audio design, sale and installation.



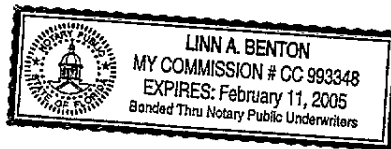
