ARTICLE OF INCORPORATION

The undersigned subscribers to these Article of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be JBA ASSETS, Inc.

ARTICLE II

Its business shall be carried on at the principal office, same as the registered office, which is at 6850 NW 2<sup>nd</sup> Ave., Suite 17, Boca Raton, FL, 33487, and the warehouse at 3508 SW Armellini Ave Unit 6, Palm City, FL 34990, and the mailing address shall be P.O.Box 812224, Boca Raton, FL 33481-2224, in the United States of America, and elsewhere, as may be authorized by its Board of Directors.

ARTICLE III

The general business to be transacted by the corporation shall be to buy, sell, lease, of real estate properties, motor vehicles, and to do any and all other business incidental, necessary or helpful thereto.

To apply for hold, purchase, acquire or otherwise deal in letters patents or copywriters of the United States or other countries; to work, operate or develop

the same or to carry on any business, manufacturing or otherwise, which may directly or indirectly affect those objects or any of them, to guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of any bonds, securities or other evidence created by any person or corporation of this State or any other State, Nation, or government and privileges of ownership, including the right to vote thereon as natural person might or could do.

To enter into, make perform contracts of any kind with any person, association, corporation, municipally, body politics, county, territory, state, government or colony, or any dependency thereof, and without limit as to the amount, draw, accept, endorse, discount, execute, and issue promissory notes, drafts, bills of exchange, warrants, lads, debentures, and all other negotiable instruments and evidences of indebtedness, whether secured by mortgage, bond or otherwise, as well as to secure the same by mortgage, bond or otherwise.

To do any and all of the things herein set to the same extend as natural persons might or could do and in any part of the world as principals, agents, contractors, or otherwise, and either alone or in company with others, purchase hold and re-issue any of the shares of its capital stock.

#### ARTICLE IV

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 500 shares of \$10.00 par value.

The amount of capital with which the corporation will begin business shall be five Thousand (\$5,000.00) Dollars.

#### ARTICLE V

The number of Directors of the Corporation shall be two (the second Director to be elected at the first meeting of the Corporation).

The corporation shall have perpetual existence.

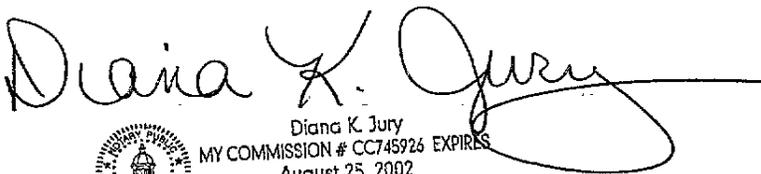
