# INCORPORATION OF KELLY'S KIDS, INC.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

### **ARTICLE I**

NAME: The name of the corporation is KELLY'S KIDS, INC.

#### ARTICLE IX
