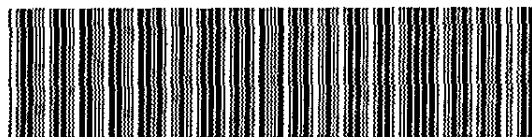

The Corporation is hereby authorized to issue 5,000,000 shares of common stock, all of one class, at \$0.01 par value.

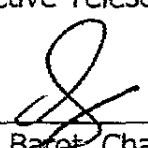
**Third:** The effective date of the adoption of these amendments is May 14, 2003.
