ARTICLES OF INCORPORATION

Pursuant to the provisions of Sections 621.13 and 607.1006, Florida Statutes, SOUTH FLORIDA VASCULAR ASSOCIATES, P.A. (the "Corporation"), adopts the following amendments to its Articles of Incorporation:

1. Article I is deleted in its entirety and the following text is substituted:

ARTICLE I. CORPORATE NAME

The name of this Corporation is: SOUTH FLORIDA VASCULAR ASSOCIATES, INC.

2. Article III is deleted in its entirety and the following text is substituted:

ARTICLE III. NATURE OF CORPORATE BUSINESS


The Corporation is organized for the purpose of transacting any and all lawful business including, without limitation, the provision of health care goods and services.

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.

4. The amendments are adopted on June 30, 2015.

5. The amendments to the Articles of Incorporation were adopted by the sole shareholder by written consent. The number of votes cast for the amendments by the sole shareholder was sufficient for approval.
