

ARTICLES OF INCORPORATION

OF

THE IMUA COMPANY

ARTICLE I - NAME

The name of this corporation is THE IMUA COMPANY.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

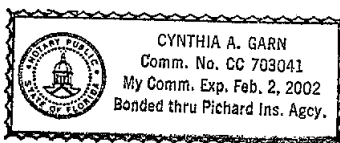


