

ARTICLES OF INCORPORATION

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation shall be: SOUTHERN SPECIALTY PRODUCTS, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office of the Corporation shall be located at P.O.
