**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of CAMEO HOMES OF CENTRAL FLORIDA, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**




