ARTICLES OF INCORPORATION
of

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is: **RFTEK, INCORPORATED**

ARTICLE II

PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 1445 Valley Pine Circle, Apopka, FL 32712. The mailing address of the corporation is the same.

ARTICLE III

CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE IV

PURPOSE OR PURPOSES

The general purposes for which the corporation is organized are:

1. To transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE V

CAPITALIZATION

The total number of shares of stock which the corporation is authorized to issue is fifteen thousand (15,000), all of which shall be Common Stock, with the par value of One Dollar (\$1.00) per share. All Common Stock shares shall be identical with each other in every respect and the holder of Common Stock shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

PREEMPTIVE RIGHTS

The holders of shares of the corporation shall have preemptive rights to subscribe or purchase from the corporation any shares authorized but unissued, or any newly authorized shares.

ARTICLE VII

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1445 Valley Pine Circle, Apopka, FL 32712, and the name of its initial registered agent at such address, is William A. Drafts.

ARTICLE VIII

INCORPORATOR




CONSENT TO SERVE AS REGISTERED AGENT
