#### ARTICLES OF INCORPORATION

OF

#### Basic Care, Incorporated

#### ARTICLE I - NAME

The name of this corporation is Basic Care Incorporated.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of the State.

#### ARTICLE III - PURPOSE

The general purposes for which this corporation is organized are:
