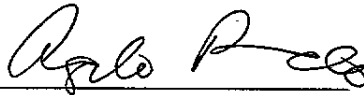

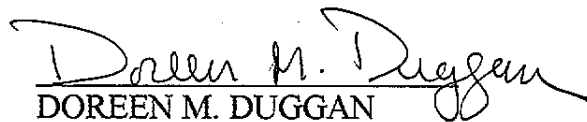
CERTIFICATE OF REGISTERED AGENT
