ARTICLE I - NAME

The name of this corporation is **BED BOUQUET INDUSTRIES, INC.** The principal office and mailing address of this corporation is: 1133 S. University Drive, Suite 202, Plantation, FL 33324.

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

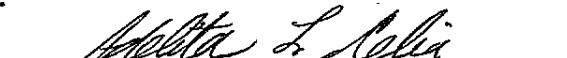
